For an increasing number of people, the aesthetic appearance of teeth is gaining in importance. Discoloured teeth affect not only your looks, but rather have an influence on your overall appearance and make the patient wish for a suitable tooth whitening treatment. Lightening the colour of teeth with whitening gel provides an option for restoring dental aesthetics which is as effective as it is gentle.

Depending on individual preferences, you can choose a version of Perfect Bleach with either 10 % or 16 % carbamide peroxide (corresponds to 3.5 % or 6 % H₂O₂). By opting for Perfect Bleach, you choose a system which corresponds to the familiar VOCO quality and thus meets your aesthetic requirements as well as those of your patients.

Discolouration

In general, there is a differentiation between internal and external tooth discolouration. If the cause of the discolouration is known, you can suggest a suitable treatment method to your patients.

Colourings in foodstuffs and drinks such as curry, coffee, red wine and tea, tobacco consumption, coloured deposits in cracks in the enamel and discolouration due to age can all cause external discolouration. Internal discolouration often occurs during tooth development. This may be caused by the side effects of medication such as tetracycline, as well as discolouration due to pulp necrosis. Since discolourations of this type are located in enamel and dentine, they cannot be removed mechanically, e.g. by professional tooth cleaning.

In such cases, a whitening treatment is appropriate.

Perfect Bleach® 10 % / 16 % – in practical sets

Perfect Bleach is a carbamide peroxide-based whitening material. Depending on the extent of the discolouration, you can choose a concentration of either 10 % or 16 % (corresponds to 3.5 % or 6 % H₂O₂). Following initial treatment at the practice, the patient can continue to use Perfect Bleach at home.

Perfect Bleach comes in various forms of presentation, including two different sets. In addition to the carbamide peroxide syringes, the mini set includes a storage case for the trays as well as a practical cosmetic bag. The full set, on the other hand, comprises the carbamide peroxide syringes, a shade guide for verifying the success of the treatment, the storage case for the trays and a cosmetic bag. In addition to the patient utensils, you will find all of the materials which

are required for the fabrication of the trays. This includes two deep-drawing films, the Block Out Gel LC and the instructions for use for both the dental technician and the dentist.

Perfect Bleach® – Gentle yet effective

Studies confirm that highly dosed whitening gels do not lead to a significantly better whitening effect [A. Braun et al, Dent Mater 2007; 23: 165 - 169]. Distinct whitening success can be achieved using low-concentration gels, which treat the dental hard tissue gently at the same time. Perfect Bleach has a sufficiently high concentration of carbamide peroxide to act against discolouration in a way which is at once effective and gentle for the patient. The fluoride and potassium contained in Perfect Bleach ensure that hypersensitivity is prevented during and after treatment.

Advantages for your patients

Perfect Bleach is very easy to handle and user-friendly. The consistency of the gel prevents gingival irritations as it does not run out of the tray. Another advantage is that a short wearing time is sufficient. The gel takes full effect within the first two hours following the insertion of the tray. The first sign of the success of the treatment becomes evident after only the second application. The fresh mint aroma of the gel is pleasant for the patient, too.

The Council Directive ensures that tooth whitening or bleaching products containing more than 0.1 % and up to 6 % of hydrogen peroxide may be sold to dental practitioners only. The first application of each cycle of use must be carried out by a dental practitioner or under their direct supervision. Subsequently, these products may be given to the patient to continue the treatment at home. In addition, these products are not to be used on patients under 18 years of age.
